COMMANDER DESTROYER DIVISION FIFTEEN'S WAR DIARY FOR THE MONTH OF AUGUST 1943:

This war diary is written in accordance with Commander-in-Chief, W.S.Fleet restricted letter FF1/Al2-1/Al6-3, serial 2899 of October 19, 1942. Numbered paragraphs refer to paragraph three cf subject letter. Information relative to ships movements may be obtained from the war diaries of U.S.S. LANG, U.S.S. STERETT, U.S.S. WILSON, and U.S.S. STACK.

1 August 1943:

- (1) Task Group 31.2, under operational control CTF-31.
- (2) CTF-31 operational plans in effect.
- (3) 0800: Patrolling off Onaiavise Entrance, New Georgia. 1200: Three miles N. E. of Tetipan Island, New Georgia. 2000: 8-22 S. 159-10 E.
- (4) Steaming with STACK and STERETT escorting five LCI's to Onaiavisi Entrance, New Georgia. Formation speed ten knots, patrolling at twelve knots. At 0331 entered Blanche Channel. At 0700 LCI's commenced landing operations. USS LANG, STACK and STERETT, patrolling. At 0825 six enemy dive bombers bombed friendly landing craft at Onaiavisi Entrance. USS LANG opened fire on the dive bombers, and at 0825 one Japanese dive bomber made near miss of about one hundred feet off port bow of LANG. Bomb estimated to be one hundred pounds, fragmentation type. Several small holes made by shrapnel, all above main deck. No casualties to personnel. Attacking plane hit by 20 m.m. of LANG's and left smoking and was seen to crash in jungle. At 1051 departed with LCI's enroute Purvis Bay. At 1551 LANG and STERETT left formation proceeding to rendezvous with Task Group 31.2. At 1856 Rendezvoused with Task Group 31.2; U.S.S. MAURY (O.T.C. and guide, CDD-44), GRIDLEY, CRAVEN, and WILSON. Formed sections as follows: First; MAURY, GRIDLEY and CRAVEN; second; LANG (CDD-15 Com-Div-A-2), STERETT and WILSON. Set course for Kula Gulf. At 2347 entered Kula Gulf.
